# The Life and Death Story of Albert Afraid of Hawk, Lakota. Sioux

Dr. Nicholas Bellantoni, State Archeologist will present this month's program which is co-sponsored with Waterford Public Library Dr. Bellantoni will tell us the story of this Lakota Sioux who died in Danbury, CT in June 1900 while performing with Buffalo Bill's Wild West Show. He was buried in an unmarked grave in Wooster Cemetery. In 2008, a local historian found the cemetery archives and the burial location. Family members on the Chevenne River Sioux Reservation requested that Albert's remains be returned to the reservation for burial according to his Lakota heritage. The presentation tells the life and death of Albert Afraid of Hawk, the story of the Lakota people, the archaeological exhumation, forensic identification and repatriation of his remains.

# Top Secret Rosies: The female Computers of World War II

When the United States entered World War II, the Army initiated a national call for women mathematicians. In fact, AAUW was one of the organizations contacted for help with recruiting! LeAnn Erickson tells us that AAUW "helped spread the word about this great opportunity open to college women." She was able to use the letter specifically addressed to AAUW in a documentary she has done. These "computers" — then the term for someone who computes, rather than our current notion of the machine — would be responsible for calculating ballistics tables for missiles being used by allied forces overseas. The stakes were high, and these women worked hard on their mission at the University of Pennsylvania from 1942 to 1946.

Irene Finkelstein reminded members that September 24<sup>th</sup> is National Voters Registration Day.


