Author and Journalist Susan Campbell will speak at our April meeting about her book *Tempest-Tossed: The Spirit of Isabella Beecher Hooker* and the stormy relationship she had with Samuel Clemens.

The wife of attorney John Hooker, one of the founders of the Nook Farm community, Isabella Beecher Hooker served as hostess to Samuel L. Clemens -- Mark Twain -- on his early visits to Hartford and as landlady to both Samuel and Olivia Clemens in the 1870s while they were building their great home on Farmington Avenue. Clemens and Hooker split over the issue of an alleged adulterous affair involving her brother -- the famed abolitionist preacher Henry Ward Beecher. The trial that resulted had Clemens defending Beecher, and Hooker on the other side of the fence. But affection survived this rift: When she died in 1907, Clemens returned to Hartford to serve as a pallbearer at her funeral.

Hooker was an enemy and friend to reckon with --"a curiously modern nineteenth-century figure," as Campbell calls her. She was a leader in the suffrage movement, and a mover and shaker in Hartford and Connecticut. She was also an ardent Spiritualist. The biography reveals Isabella's evolution from orthodox Calvinist daughter, wife, and mother to one of the most influential players in the movement for women's suffrage, where this unforgettable woman finally gets her proper due.



Susan Campbell is the author of the memoir *Dating Jesus: Fundamentalism, Feminism, and the American Girl,* winner of the Connecticut Book Award, and co-author of *Connecticut Curiosities*. She has appeared on *CBS News Sunday Morning*, the BBC, and


